AN EXECUTIVE ORDER EXTENDING FROM MARCH 23-APRIL 11 TO APRIL 12 UNTIL 11:59 OF APRIL 30, 2020 PLACING THE ENTIRE MUNICIPALITY OF SALCEDO, EASTERN SAMAR UNDER MODIFIED ENHANCED COMMUNITY QUARANTINE

WHEREAS, the Municipality of Salcedo through an Executive Order No. 158 series of 2020, placed the entire Municipality under a Modified Enhanced Community Quarantine from March 23-April 11, 2020, to make sure that Salcedo will be COVID-19 virus free.

WHEREAS, the National Inter-Agency Task Force (NITF) For COVID-19 extended the enhanced community quarantine in the entire Luzon until 11:59 of April 30, 2020.

WHEREAS, during the Joint Municipal Disaster Risk Reduction Council and the Expanded Local development Council Meeting last April 6, 2020, where almost all of the Municipal Inter-Agency Task Force Members are present, were convinced that we should extend the enhanced community quarantine.


WHEREAS, the Regional Office 8 of the DOH confirmed a local transmission in the Municipality of Tarangnan Samar, which strengthened our resolve to continue mobilizing frontliners in keeping the Municipality COVID-19 Virus Free.

WHEREAS, due to these recent developments, the Local Government Unit of Salcedo decided to continue and extend its Modified Community Quarantine to protect its constituents and remain free of COVID-19 virus.


NOW THEREFORE, I **ATTY. MELCHOR L. MERGAL**, Municipal Mayor of Salcedo, Eastern Samar, by virtue of the powers vested in me by law, do hereby order the continuation/extension of the Modified Enhanced Community Quarantine from March 23-April 11 to April 12 up to 11:59 of April 30, 2020, adopting all the provisions of the previous Executive Order No. 158 and all the corresponding agreements with the barangay captains and all stakeholders as regards the parameters for its execution.

Section 1. Effectively. This order shall take effect immediately on 12:01 April 12, to April 30, 11: 59, 2020 or sooner lifted by the Municipal Inter-Agency Task Force.
